Classroom and Driving to be conducted at AAA Findlay Automobile Club. Course will consist of **24** hours of classroom and **8** hours behind the wheel instruction. The behind the wheel instruction will be scheduled after the classroom portion is finished. This training agreement expires on ___/___/___ . After this date, this contract is null and void, unless alternate arrangements have been made with the driving school. Once training has commenced, **NO** refunds will be issued.

The total cost is **\$300** for non-AAA members and **\$290** for AAA members. **Additional lessons or use of our vehicles for the state test is an option at \$30 per hour.** The AAA Driving School will furnish a licensed instructor and a vehicle equipped for instruction. AAA Driving School does not guarantee the State of Ohio issuance of an operator's license to the student. Students may practice maneuverability with cones in our parking lot when in place as long as it doesn't interfere with an established lesson in progress.

The school is willing and able to provide proper, professional instruction. Mature behavior is expected. If the student's behavior is disruptive or interferes with the instructor's ability to continue lessons, the student will be asked to leave and tuition will not be refunded. No smoking, food, beverages, gum, candy, etc. will be permitted in the classroom or building. Classroom participation is a significant part of the curriculum. Students who do not participate in all activities will not receive a Certificate of Completion required by the State of Ohio. Certificates of Completion will be issued once we can verify all requirements have been met. Please allow a minimum of 2 business days for issuance of certificate. Appropriate dress & footwear is required. Please respect property and equipment. Classes and behind the wheel instruction is filled on a first come, first served basis. AAA Driving School will not reserve a student's space unless payment is received. "No shows" will be rescheduled at the expense of the parent at \$30 per hour. Lost certificates require a replacement fee of \$10. Temporary Permit Package is required for any behind the wheel instruction. Training will be completed within six months from the start of classroom instruction.
